
To pay bills by exchanging Payment to Supplier files, it is now mandatory to inform the beneficiary's CNPJ/CPF.

In the payment file, this information must be included in segment J52 of the aforementioned layout, as detailed on page 21 of this Manual.



# 1. COMPOSIÇÃO DO ARQUIVO

The Bank-Company Information Exchange File consists of a file header record, one or more service batches and a file trailer record, as illustrated in the figure below:



With the structure presented, a single file can contain several lots of different services.

#### **SERVICE LOT**

A **service lot** consists of a batch header record, one or more detail records, and a lot trailer record. A service lot can only contain a **single service type**.

#### **DETAIL RECORD**

A detail record is composed of one or more segments, depending on the type of service associated with the service lot.

There are several different types of segments and each of them can be used in one or more service lots, both in the Remittance flows (Customer sending information to the Bank) and in the Return flows (Bank sending information to the Customer), as detailed below:

#### **RECORD SIZE**

Record Size is 240 bytes.

#### **FIELDS ALIGNMENT**

Unformatted numeric fields: padded with zeros

Formatted numeric fields: Always on the right and padded with zeros on the left. Alphanumeric fields: Always on the left and padded with blanks on the right.



#### 2. NOTES

#### **2.1. DEADLINES AND TIMETABLES**

- a) The FLOAT negotiated in the Agreement must be taken into account.
- b) The transmission of files containing payment options via TED and Securities above the Reference Value must comply with the BANK's current deadline. For other payment methods provided for in this Agreement, the transmission of files must be made no later than 8:00 p.m. (Brasília time) on the day determined for payment or on the day of debit in the event of debit of funds prior to the payment date..

Files containing payment requests sent after the times defined above will be rejected and the CLIENT will be informed by sending a return file (if contracted), and the BANK cannot be held responsible for the non-effectiveness of payments.

The authorization of commitments, for payments by TED and Securities above the Reference Value, must be made in compliance with the deadline in force at the BANK. In other cases, the authorization may be made up to 8:00 p.m. (Brasília time) on the day of payment.

The cancellation of scheduled payment commitments will only be acZip Codeted by the BANK if the command is received by 8:00 p.m. on the business day immediately prior to the respective payment.

For clients without float payments/transfers via Pix, the commitments must be scheduled/authorized by 11:00 p.m. and 10:00 p.m. (Brasília time) on the day of payment on business days. On non-working days, until 7:20 p.m. (seventeen hours).

In the case of QR Codes, appointments must respect the due date/time (if applicable).

#### 2.2. LOGICAL SEQUENCE CONTROL:

Once the functionality has been contracted, the CLIENT may send files following a numerical logical sequence control, observing the following:



- a) Restricted Sequence Control each file must include the number following the one previously sent;
- b) Different Sequence Control each file can receive any sequential number, as long as it is not the same as those assigned to any of the previously sent files.

If this functionality is not contracted, there will be no control of this sequence.

#### 2.3. SEQUENCE CONTROL FOR FILE TESTING:

If this functionality is contracted, any file containing a logical numerical sequence from 1 (one) to 10 (ten) will be treated as a test, and no payment should be processed under these conditions.

If this functionality is not contracted, files with this numerical sequence will be treated as a normal file for payment purposes.

#### 2.4. YOUR NUMBER MANDATORY

If this feature is purchased, the "Your Number" field will be mandatory and cannot be repeated together with the same "Supplier Registration Number" (CPF / CNPJ), "Payment Date" and "Payment Amount".

If this feature is not purchased, no criticism will be made regarding the "Your Number" field, which may be duplicated or not provided.

#### 2.5. DAILY PAYMENT LIMIT VALUE LOCK

If this feature is contracted, only payments up to the limit stipulated for total payments on the day will be included. Amounts that exceed the amount stipulated by the CLIENT in the value lock will not be settled and the CLIENT will be informed by means of a return file, using the error code HF.

#### 2.6. RETURN FILE

If this functionality is contracted, the BANK will send the CLIENT a review return file through the channel determined by the CLIENT.

Regardless of whether or not the CLIENT has opted to receive the review return file, the BANK will make available on Internet Banking a report indicating any errors or inconsistencies found in the file sent by the CLIENT.

#### 2.7. PAYMENTS ON NON-WORKING DAYS

If the date set for payments falls on a non-business day or a day without banking hours in the location where payments are to be made, the BANK will consider the first business day following the originally scheduled date. For Pix, payments/transfers can be made on a non-business day.

For taxes that do not allow payment on the following business day, whose due dates fall on weekends or holidays or on a non-business day in the location where payments are to be made, the CLIENT must indicate when scheduling the payment the date on which such payments are to be made.





Amount or percentage of the value of the title to be charged as interest on arrears.

#### **C013. Discount Code 1 / 2 / 3**

Code adopted by FEBRABAN to identify the type of discount that should be granted. When choosing value, the three discounts must be expressed in values. Likewise, when choosing percentage, the three discounts must be expressed in percentages. Domain:

#### N002. Bar Code

Refers to the Bar Code captured by an optical reader (Information in the upper right and/or in the center of the lower part of the document).

If captured by typing the numerical representation contained in the boxes located in the upper part of the Bar Code, pay attention to checking the verification digit of the fields, and convert to Bar Code. The DV of each numeric box (positions 12, 24, 36 and 48) must be disregarded.).

ATTENTION! The taxes and concessions that can be collected through the bar code are:

- Federal Taxes: GPS, Simples Nacional, DARF, FGTS, DPVAT, INFRAERO and Airport Tax, etc.;
- State Taxes: IPVA, GNRE, GARE-ICMS Import, DARE, DAE, DAR, Traffic Fines, etc.;

#### N007. Additional Tax Information

Complementary use for tax payment.

#### N008. State/Federation Unit

Enter the abbreviation of the State component of the Address used for mail delivery.

In the case of DETRAN payments (IPVA, DPVAT, Licensing), "SP", "PR" or "MG" must be entered, depending on the UF in which the vehicle is registered. If a UF other than "SP", "PR" or "MG" is entered, the record will be Rejected in the file review, returning the code "AJ". If the UF is not entered, the system will assume it is "SP"."

## N009. City Code

Enter the City Code in which the vehicle is registered. Obtain this information from the Vehicle Registration and Licensing Certificate – CRLV.
